- Contribute to development of volunteer work and the wider use of volunteers.




Education is only worth its application, which is why AngloAmerican University's Career Center (AAU) strives to help student connect with various partners in Prague to provide them with practical experiences. AAU believes such opportunities help empower students to be responsible global citizens through enabling them to understand how their education and skills fit in an applied, global context. Centrum Narovinu has been one these important partners to AAU and the AAU Community. Since 2016, Centrum Narovinu has provided nearly a dozen internships to their international students, mostly from their Humanities and International Relations faculties. Students have had the opportunities to help with content creation, research and communication outreach during Charity events for Island of Hope, which was spearheaded by our student with Centrum Narovinu.

#### Elizabeth Novacek, AAU Career Development Specialist

In 2004, we began to consider a long-distance adoption of a child in Africa. After searching for an information on the Internet and visiting Center Narovinu in Prague, we adopted a girl from Kenya called Metrine Midesha, who was 18 years old. 15 years have passed, Metrine with our financial support completed primary and secondary school and furthermore she studied tourism management. After 15 years of financial support, it was logical that we wanted to see the results of our help with our own eyes. Kenya was exotic and totally unknown to us and we were afraid of the visit. Nevertheless, we decided to buy the tickets during her spring holiday. And so there was no way back. It was a wonderful meeting. For the first time we saw our girl in a real life, from whom we first received only pictures, then very simple messages and later on longer letters with plans for business and for life of independent and successful women. Metrine surprised us with her straightforwardness and inteligence. Our goal was to get to know as much as possible the environment in which she grew up and at the same time take her somewhere where we could discuss her other plans and give her the opportunity to see and experience something completely different. We met not only our adopted daughter, but also a granddaughter, Metrine's mother and coordinator Beatrice. We also took a look at her very modest clothing store and listened to how she wanted to move her business a little further. It was here that we realized that even though it was a

very simple slum booth, the purchasing power, albeit at a different level than we are used to, is simply here, and the whole business idea makes perfect sense. We suggested to take Metrine with us to Diani Beach near Mombasa for a few days and also to safari to Tsavo National Park. For the first time, Metrine saw the sea, and although she studied tourism with a focus on safari, she was actually in the national park for the first time. She evaluated everything as a great asset. She saw the way animals are searched for so visitors can see them in their natural life, how the par*k*'s visitors behave and what they are interested in, how the hotel works in the park... it was not only a wonderful experience but also a great lesson. On the way back to Nairobi (we tried newly built railway), we were discussing more business options, economic indicators, and modest ways of upgrading and refurbishing of the store. Last day in Nairobi, we only checked the view from the tower of the International Convention Center. It was obvious that Metrine knows all the places in the center of Nairobi, where she lived basically all her life. She walked us all the way to the airport and we all knew that we didn't see each other for the last time. We would like to see her as a successful woman who can use what she has learned. And we want to continue helping her. If she is able to help other people in need as well, all our support will have the real meaning.

# Our projects

# African Child Adoption – Long Distance Support Project

The poverty is often caused by low education; therefore, it is very important to support education of children, to try to help them to a better future. Regular school attendance is still a major problem for children from poor areas of Kenya - girls often don't even finish primary education. We give the same opportunity to girls and boys. The project has started in 2002 and we count hundreds of students in the universities. They want to live differently and they would like to actively contribute to the society.

### Health care program

For a long time we have experienced that children have to leave school due to common illnesses. The cost of healthcare is very high and their families do not have enough money for the treatment. In order to help in this situation, we set up a Healthcare project in 2008. The aim of the project is to inform about common illnesses and about how to prevent them as well as support when treatment is needed. Nearly a thousand children are part of the project every year.



### Project in 2019 in numbers:

- 1 585 children were studying in the 1st trimester, in the 2nd trimester 1 561 children and in the 3rd trimester 1 538 children.
- In the 1st trimester 68 kids attendeded the nursery, 438 pupils attended the primary, 553 students attended the high-school and 526 students studied at the universities or colleges. The program supported 860 girls and 725 boys.
- Within the Club of Friends of Adoptin, **64** children were supported in the 1st trimester with a total amount of 245 200 CZK, in the 2nd 56 children with a total amount of 256 947 CZK and in the 3rd 57 children with a total amount of 255 200 CZK.
- The health insurance program provided health care for 683 children. A total of 481 medical cases were addressed, of which 30 were hospitalized. All the children went through a preventive medical examination.
- There are 20 coordinators in the Czech Republic and 22 teams in Kenya in charge of the project.
- A great benefit was also 4 interns.
- We have completed 201 new long distance adoptions in one year.
- 6 adoptive parents visited their supported children in Kenya.
- Adoptive parents have managed to provide us an extra 147 contributions totalling 390 562 CZK for Kenyan families and their everyday costs - especially food, vaccination, bikes, costs of school necessities, and notebooks for university students.



**My name is Gilphers Oduor Mukoya** and I am a volunteer coordinator for Centrum Narovinu for Kakamega County, the second largest county in Kenya and one with the highest number of secondary schools. I have a passion for the education of children and I always make sure that I do all that I can to ensure that children have access to the education. In my county, there are many children who have been able to attain secondary and tertiary education thanks to Centrum Narovinu's management's efforts. I thank the Czech team, adoptive parents and the Nairobi office for the wonderful work they continue to do in providing a decent future for the vulnerable children of Kakamega County.



**My name is Bohuslava Dusíková** and I have been teaching at the local primary school for 14 years. In 2007, our school decided to adopt a child in Africa and since then we have been supporting the girl Muthina, who is a high school student today. And since then I have been following the activities of the Centre Narovinu... When there was an opportunity, I took part in discussions with Kenyan adoption coordinators in Prague or teachers from school on the Island of Hope. I was meeting people connected to the Centre Narovinu, and I started to participate in the various activities of the Centre. I have been also considering the idea of becoming a volunteer coordinator for a long time. I became coordinator in January 2019. I have been over the years through the project of long distance adoption gradually supporting three children. In 2016, 2018 and 2019 I managed to

visit Kenya and see everything with my own eyes. Meeting with adopted children was definitely worth it! Perhaps it is related to my work that the issue of distance adoption and access to education seems interesting and also very important to me.

**If Melsa (ID 52391) did not have health insurance,** *she would not know about her recurrent illness. Thanks to the program, the girl goes for regular checks and examinations. That is how doctors found out that Melsa* 

had typhoid three times in six months. Quick-witted and conscious adoptive mother offered to help and use the extra payment for the vaccination against the typhoid. Hopefully, the girl will avoid this illness and will be smiling again.



#### Alexandra Yaklyushyna

Anthony's mother died when he was very young. He has an older sister and brother, they all live with their father and grandmother. One of our adoptive parents said: Anthony is the first child who I support through Centrum Narovinu and we know each other very well. We write to each other and send each other pictures. I look forward very much to meeting him and his family. His father and grandmother write me letters as well.



I can see James (Anthony's father), he is waiting for us and waving with a big smile. What a warm welcome - hugs followed by meeting grandmother and Anthony's sister. It was so emotional that the grandmother started to cry. She cannot believe that we actually arrived at their tinny house. She stands up with difficulties and gives me a hug. She always wrote me in her letters that this is her dream to meet us face to face and now the dream came true. We brought some presents, medications and some cream for her health issue, which she wrote me about. To memorize such a powerful moment, we took some pictures. We talked and laughed a lot. Anthony's father is very funny, even though he is sick (HIV) and carries a huge responsibility for his three children and his ill mother. I admire him, considering his difficult situation he can still laugh, make jokes and is very heart wellcoming, He has to be a very strong person with a big heart.

Finally, with a big smile my beloved Anthony is coming. I am so excited to meet him! I could not stop hugging him. We have dreamt about this special moment so many times in our letters. We are both so happy. What a life-changing moment.

Then, we went to Gakinda to see my Ayub, who was very surprised in the class! The boy knew we were going to visit him, but he didn't know exactly when and where. So, he was even more surprised than us when we saw him! In the school garden, the director and then Ayub's class teacher welcomed us very warmly. When Ayub saw us, he recognized us immediately. He was looking at us in total astonishment and at the same time with a

happy, shy smile. When the teacher allowed him to come to us, he came and greeted us with a huge hug. We took the boy home from school, where Ayuba's mother (a widow with 4 children) was waiting impatiently for us. Then, they invited us home where we had a very good lunch (chicken, potatoes, vegetables, ugali, chapati, many fruits, bottled water, cola, fanta etc.). All of this was prepared for us by his mother together with the other women from the village. The whole village took part in the preparations; everyone gave something so that Ayuba's mother could serve us this way. She couldn't afford such a feast by herself. The countryside is so beautiful in Kenya. It is good to see that there is still a community way of life there. *The family lives in a tworoom wooden house. The* roof is only made of wood-loaded sails. We were in the dry season in Kenya and I don't know how much a roof performs its function when heavy rains come. Only few of us can really imagine having a wet bed because it rains outside. By visiting my Ayuba, his very cordial mum and the other women of the neighbourhood, we could see with our own eyes that our support is very much needed there!

## Community centre Island of Hope on Rusinga Island in Kenya

We have been creating a sustainable center since 2003 together with a local community, which provides an access to a high quality education to very poor people and children from Kamasengre area on Rusinga Island with respectful, non-violent approach and also access to basic medical care. Last but not least it has set an example of how to improve living conditions throught the use of sustainable technologies and coperation and solidarity.

In 2019 we focused on orphanage home, school, nursery, grammar school, border school, clinic and farm.

Thanks to financial support from the Czech and Slovakian donors as well as development agency SlovakAid we were able to buy a multifunctional car in January 2019. This car will be used for the needs of Island of Hope. It will be used for transport of students to different school events such as sports games, conferences then it will be used as an ambulance car, for shopping, and the necessity of the farm.

The project has been significantly and in the long term supported by the official development cooperation of Slovakia as a part of the SlovakAid project: In September 2019, ended 2-year long project "SAMRS/2017/KE/1/1 – Fish breeding farm in Victoria lake ". The project supports the sustainability of the existing community centre Island of Hope. A part of the project is also a realisation of a one-yearlong seminar on sexual education, planned parenthood, interpersonal relations and other topics which are a part of the school subject "Life Skills".

"

**My name is Sauline Ouma** and I joined Island of Hope in 2013. Orphan children live and learn here and I enjoy being with these orphan children because I am an orphan too. I am a teacher in the primary school section and I teach pupils in grade one. I have learnt a lot in this institution, especially about non-violence. This



has helped me to solve many problems even back at home. These pupils are free and they share with me some of the problems they undergo in their various homes. Guiding and directing them has helped them overcome some of the problems they face.

I remain grateful as I start my 4th year serving in the position of the clinical officer in Centrum Narovinu, Rusinga Island of Hope clinic. It has been great working together, as we ensure that our clients get the best service possible. I joined Centrum Narovinu in December 2015 and I am happy that this organisation has made me a more responsible and dedicated person I am today. **My name is Marie Langova** and I spent half a year with my colleagues Zuzana Klečková on Rusinga Island in 2010. Health center was already built at that time. We helped setting upthe operation of the clinic and cooperation with surrounding state institutions and local hospital. I am happy from the fact that the health center is still developing. There are ambulance, laboratory, small maternity departement and few beds for short term hospitalisation today. The whole service is done by local people and all are led by reliable Chris Ninah. Nowdays, we cooperate remotely. We help with consultations of different cases, ordering drugs and medical supplies, launch new services and follow up of those already running.

I 'm Jack Mangana and I started volunteering in Centrum Narovinu, Rusinga Island in 2001. In this organisation, I take photos, collect report forms and letters from the sponsored children. Besides that, I fill the forms for the new children to be put in the adoption programme, and also assist children/families who cannot write letters to their sponsors. Let me say many thanks to the organisation, all the adoptive parents, because you have made it possible for the poor, orphans and unfortunate families to go to school.

**My name is Pamela Achteng Oheno** and I am currently working as a head of kitchen department and I am responsible for the food store and food preparation for all the children on the Island of Hope, it means approx. 500 children. I enjoy especially the orphanage children because I feel like their mother as they do not have their own parents. I am really thankful to be a part of this project since 2004.

## Project Africa by unusual eyes

We are trying to mitigate concerns about immigration and their tendency to misinformation, intolerance and xenophobia...We have a good experience from different projects on breaking stereotypes. We organize global development education programs in schools. Cooperation between Kenyan and Czech schools, and we also organize awareness-raising events for the general public.

### **Project in 2019 in numbers:**

- Development-related project days took place in **16** schools.
- 10 schools from the Czech Republic and 10 schools from Kenya took a part in a project Partnership between schools. Most of them focused on the theme of Tradition and traditional clothing in the school year 2018/2019
- 29 educational events were organized

Activities were chosen accordingly to children age. Also the main message – children adoption from Kenya – has high benefit for next education of pupils. The cooperation with Centrum Narovinu helped us to get new knowledge and fulfill part of our multicultural educational plan. We wish many successes to Centrum Narovinu in their beneficial work.

My name is Lydia Njoroge, I come from a family of five children and I was raised in Nairobi. I am also a wife, a mother of four and a grandmother of one. Having worked as a nursery school teacher in my youthful age, I found interaction with young children fulfilling, which inspired me to join Centrum Narovinu as a volunteer coordinator. Aside from that, I am also a passionate motivational speaker to both young adults and women from diverse backgrounds.

My name is Christine Juma, I have been a volunteer in Centrum Narovinu since 2009. I coordinate children in Nairobi, Dagoretti Sub-Conty where I live. I like working with children from different backgrounds,

needy, orphans and those from humble families. I like when children from these families are supported in education and become responsible members of their family, Community, Nation and the World at large. I also work as a Community Health Volunteer in my Community to uplift health standard of my people by visiting and educating them on the importance of health. I also reffer the sick to our Public Health facilities, supply family planning commodities, counseling etc. I love my work so much and I believe one day our voices will be heard and the name will change from the community health volunteer to the community health worker.



My name is Helena Havlišová and I have known Centre Narovinu since 2008. Me and my husband we wanted to try a long-distance adoption and we were looking for an organization that was transparent and where we would not only contribute a certain amount for studies of an anonymous child, but where we would have regular feedback in the form of letters, information of study results, health status. I found Centre Narovinu, thanks to which we accepted another member in our family at least remotely, and because we have two daughters, we chose a boy named Hillary. A few years later, I decided to get involved more in the organization and I became one of the coordinators of a long-distance adoption project myself. Later we adopted also Hillary's younger sister Faith. And then we visited both children during my trip to Kenya in 2014. Even though we didn't have much time, it was for me and I believe that even for "our" children, a really strong experience and to this day I remember the meeting with love. Hillary is now an adult man, he has completed high school and found himself a girl. I believe our support has given him a good foundation for life. In Centre Narovinu, as coordinators of adoption, I am in charge of a part of the adopted children database and I deal with their adoptive parents regarding everything concerning school fees, mails, health reports etc. Twice a year I meet other coordinators at the weekend workshops where we exchange our experience and learn what is new in projects in Kenya.

**My name is Lucie Valtová** and I am a volunteer coordinator of a long-distance adoption at Centre Narovinu. My collaboration with the Centre Narovinu began in late 2003 when I adopted a baby girl from Kenya. From the beginning, I really like the enthusiasm and admirable effort they put into the development and implementation of their projects in the Centre Narovinu. I also like how consistent they are in their planning, how they make sure that local people actively participatein taking over their share of responsibility and that they just do not passively accept assistance from Europe. # Shop operated in the spirit of fair trade

Products with a story are bought for Fair Shop directly from Kenyan producers and imported to our e-shop, ie. without mediators. We also offer gift certificates "Send it on" and other small items made in the Czech Republic. 100 % of earnings goes back to the project of Island of Hope in Kenya. The shop helps us to develop it in a long term.

### **Project in 2019 in numbers:**

- Profit from the shop was **394 108 CZK** and it supported the operation of the high school and the Island of Hope clinic.
- Revenue from the events increased to 279 000 CZK.
- We managed to sell goods in value of 399 219 CZK and gift vouchers in the value of 71 280 CZK.
- We sold a collection of bracelets, which was made by children of Island of Hope in Kenya. During the period of three months (October - December 2019) we sold 106 of the bracelets and received the amount of **10 000 CZK** which went to the schools of Island of Hope.
- We would like to thank to all the schools in partnership (Nursary school Vlkava, Grammar schools Staré Město, Opava, Odolena Voda, Stříbro – Kladruby, Řečany nad Labem, Stolany and Secondary school Kojetín), which were selling goods from our shop on their market. They supported us by an amount of **77 000 CZK**.

**Our students chose ,Kenya' as their topic** and they began to look for a suitable partner who would be able to help them to connect directly with Kenya. It all started with a phone call with Ms. Hertusová from Center Narovinu in Prague. The center is directly represented by coordinators in Kenya. They suggested many ways to connect in a meaningful way with Kenya. Initially, we had no idea what that connection would look like, but at the beginning of March we met in person with students from Island of Hope located in Victoria Lake. We spoke to them in English and had a tour of the school, which was established with the support from Narovinu Center. This all took place via Skype. We sent to the students in Kenya four papers developed by three of our classes during their English lessons. Our 5th grade students developed a paper on leisure time activities, our 2nd grade students wrote about customs and traditions in the Czech Republic, and our 7th grade students wrote about what they like most about the Czech Republic and what it is like to attend our school. Students from Kenya described the same topics from their point of view so we could compare how different our lives are. We also introducted our Kenvan project and the work of Center Narovinu on the Island of Hope to the public by organizing two exhibitions in Educational and Information Center in Kojetín and in GOGalery in Přerov. The exhibition in Kojetin was accompanied by drawings from our students inspired by Africa. During the exhibition, we also organized a donation campaign to provide school and sport equipment for children from the Island of Hope in Kenya. We managed to collect a big box full of crayons, felt pens, plastic, paper, balls, bats etc. Our 3rd graders also decided to make book marks with little figures from Czech bed time stories for the students in Kenya. The students from lower grades also learned about Kenya from their older schoolmates. Every month, the older students informed the younger ones about various topics related to Kenya such as history, art and music. Our project was growing and as the end of school year was approaching, the students started to think how they could thank all the partners. They came with an idea to organize event called End of Kenya Project. Friday, June 7th, 2019 was a busy day in the inner yard of VIC. The drummers from Escola de Samba Brno came to support the children from Kenya and the students organized their last performance of their play Kenya is not pink. One also has to say this play was written by students from the 7th grade and it was based on Sleeping Beauty theme. They turned the story into poem and organized a theatre play with support of their classmates and 3 teachers. It was a great event. The visitors could also buy some souvenirs from Kenya and drinks in can.

It has become a tradition in our projects to contribute to a good cause. This time the students decided to collect cans and donate the money to support the education of the children at the Island of Hope in Kenya. The tins were collected not just by students of our school, but also by people living in other towns. In the middle of June, we re--sorted the cans and drove them to a junk yard in Kojetín. We collected 400 kg of aluminum cans and 50 kg of metal plates. We would like to thank everyone who helped us to co*llect the cans. After adding up* all the money from the cans and other contributions, we got a fi-



nal amount of 8,710 CZK to support the Island of Hope project. This money will be used for tuition fees which are obligatory in Kenya (total of 4,000 CZK), purchase of school desks and chairs (2,400 CZK), school gadgets, books and textbooks (1,310 CZK) and reimbursement of specialized examinations in the local hospital for people in need (1,000 CZK).

# Fundraising & promotion

#### **Individual donation**

There are lots of supporters, who help regularly with our program African Child Adoption – Long Distance Support Project.

### Corporate partnership for development and social responsibility

We always try to develop a partnership with different companies in order to support the Island of Hope project in Kenya. For example new partnership with the company OpenWise Solutions, which has paid the cost of the computer class, running costs as well as cost of tuition for the teacher.

Another partnership in the long term is with company Kawak a Mony's design, which donates a percentage from the sales to support our project Island of Hope.

### **Cooperation with other subjects**

We took part in an expert volunteering "1000 ideas for future" where we met many non-profit organizations and companies.

Collection project GIVT.cz (community financing portal) has managed to collect the amount of 2 106 CZK. This money was used to buy school books for the high school of Island of Hope.

#### **Benefits events**

There were few benefit events in 2019, for example the one in Činoherní cafe in Prague or Anglo-american university. Other ones were organised by volunteers to support development of Island of Hope in Kenya.

### Media

We could see positive feedback on our activity in the regional televisions, printed or online editions of newspapers.

### Video clips about African children from program African Child Adoption – Long Distance Support Project

There were 5 videos made with czech subtitles mapping the life of children and their families from the poorest areas, slums and villages. The aim of the videos was to show their experience with the Adoption program. After seeing the video some new adoptive parents were interested in supporting the education of children in Kenya.
